**FY23 Assessment Collections** – Spring Early Learning Assessment, the last of the FY23 assessment windows, is set to open this Thursday, April 20. Several other Assessment windows are currently open, including the Grade 3-8 and End of Course State assessments. There are missing lists available in most assessment collections to see who ODE expects to get results for. Start looking at those files to begin cleaning up data and entering Score Not Reported reasons for students who did not test but were expected to. This should help prevent surprises when results come back later.

**FY23P Five-Year Forecast – Required Spring Update** – This collection opened April 1 for all City, Local, Exempted Village, and Joint Vocational School Districts to submit this required collection by May 31 (Community Schools report via Epicenter). ODE loads that information Monday through Friday into the data warehouse, so it is available in the ‘Advanced Reports’ the next morning.

**ODE New EMIS Training** – Online EMIS Coordinator training continues this week, with no need to register. See ODE’s website for more information, including handouts and links to join (ODE > Data > EMIS > Resources > New EMIS Coordinator Training).

**FY24 EMIS Changes** – Several FY24 changes went out last week and were discussed on the Change Call. Please start looking at the changes coming for next school year and submit public comments if you have any questions/feedback. ODE will have several additional changes out by the next ODE ITC Call, will talk about changes at the May OAEP Conference, and on the May Change Call. They are required by law to have all policy-driven changes out by May 15. They do expect additional changes in late June after the budget bill is done. Those changes will be posted for next year after that budget document is approved by the State legislature and ODE has a chance to work with the business office to get the rules together.

On the last Change Call, we discussed a future change for adding new DN elements to collect Student Information (SIS), Financial (FIN), and Human Resource/Payroll (HRP) software used by each LEA. If there are only 1-2 using a particular software, the option will be “Other”, but if there are several using a particular software, ODE would like to include it as an option. So far, these are the options they have on their work in progress list:
