

ODE ITC Call – 5/30/2023

Financial Collections (FY23) - The Five Year Forecast-Required Spring Update (FY23) collection closes tomorrow, May 31, 2023. Both the Five Year Forecast-Final Optional (FY23) and the Financial Collection (FY23) H collection windows open this Thursday, June 1, 2023. These collections are both open throughout the summer.

FY23 District Funding “wrap up” - ODE will pull data soon. Community School data for the June payment is being pulled today. Within the next couple weeks, data will be pulled for traditional districts, ESCs and JVSDs. At that point, data for the FY23 year will not be updated until the Final #1 payment, which will be sometime in August. Districts should continue to correct data and resolve issues now that the school year is coming to a close. Once data is pulled for the June payment, it won't be pulled again until the Final #1 payment, typically in August.

FY23 Graduate – ODE is working on updates to Graduation reports. The class of 2023 is the first year where permanent requirements for competency, readiness and courses come into play. Flags are being added to reports indicating if a student has met requirements based on the data submitted to ODE, and some of the older flags that are no longer needed are being removed. The Report Explanation has been updated to reflect these fields, but the fields on the reports won't be updated for a few weeks.

EMIS Change Calls - There will be no June EMIS Change calls; these have been canceled. We do expect to have the EMIS Change calls in July. By that point the state budget for the next two years should be complete, and we expect to have changes coming out of the legislature that will need to be implemented for next school year.

Q&A

Q: Is something going on with the GY Assessment missing list? The ticket submitted regarding this issue was put on hold, and other tickets had indicated districts should re-prepare to correct. The re-prepare did not work for this situation.

A: ODE is currently working on correcting the issue.

Q: Reviewing the new CTE Report - Industry Credential Career Field Points report. When looking at the report in the data collector, we see the number of rows is about 1700, but when we download the report there are only about 1500 rows.

A: The way those counts work is actually 2 separate processes. ODE doesn't count them on the fly as you generate reports because of processing and the strain it would put on the data collector. It is possible that something is out of sync between the report and the process that actually counts the number of rows. Please submit a help desk ticket so ODE staff can review and determine if there is a logic difference between the two. We have never had an issue with a report itself missing data that is there for the report, so my guess is the counting process is off and not that there are missing or extra rows.
