<u>FY19L Initial Staff/Course collection</u> – Several FY19 collections are opening this week and next, including FY19L Initial Staff/Course. Districts are encouraged to begin reporting data as soon as possible.

<u>FY18A Career Tech Assessment Collection</u> – ODE is doing more work on CTE assessment reports, so is extending this close date from Friday October 12 to Friday November 16 (manifest updated later today).

<u>FY19S SOES and SOES Contact collections</u> —Community School funding will be based on address data from Saturday as of 5pm. Some addresses were submitted over the weekend but still show as missing this morning. ODE will pull additional address data today and those updates will help some schools see adjustments disappear for addresses they submitted over the weekend.

<u>FY19S Beginning of the Year Student Enrollment</u> – ODE is now shifting their focus to Traditional and JVS (1TRD) and will be pulling data in October for their first payments based on FY19 data. Districts must submit their 1TRD collection ASAP if they have not done so yet.

FY18H Financial appeals – on Monday, October 1, ODE will start accepting appeal submissions, so districts will see the prior version of FY18H manifest which will include all record types to submit appeals. *IMPORTANT:* When districts submit appeal data for finance, they cannot leave off any record types, they must submit ALL record types, including any submitted in Supplemental, because every submission completely replaces any prior submissions. All required data for "H" should be re-reported even if the appeal was just for a single record type.

<u>FY19 reports</u> – some bugs are being worked on: 1) FTE Daily Summary report for some districts show duplicate rows within the report. Not all rows or districts, but some may see two identical rows in a report with categories that they represent. ODE does have a fix underway and the report should be cleaned up soon. 2) Tuition reports are not showing up yet, a fix is in the works for districts to begin seeing FY19 Tuition reports to review.

FY18G Grad reporting – ODDEX Grad data should be good, ODE is working on the first version of Level 2 Grad reports to come out to show who your district is accountable for. Hopefully, by first thing tomorrow morning the manifest will be updated to include reports, so districts can begin seeing grad cohorts calculated under the new system. ODE is not considering extending this collection, because there is an Appeals window (if districts need to request a change in student cohort) which will take longer than usual, Federal reporting is due in the Fall, and Grad Rate must be published in December.
